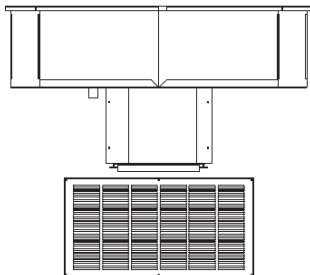

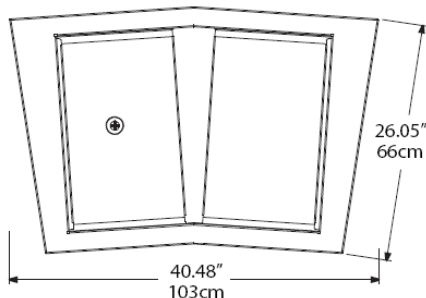

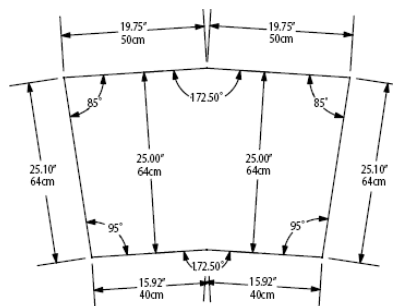
CWC-2 Elevation View
