BENEFITS

CC1E extended service cartridge contains radial flow granular activated carbon (GAC)

INSTALLATION TIPS

Choose a mounting location which is suitable to support the full weight of the system when operating (30 lbs.)

Install on cold water lines only

Do not install where unit is exposed to direct sunlight

OPERATION TIPS

Change cartridge on a regular 6 month preventative maintenance program

Change cartridge when capacity is reached (15,000 gallons) or when flow becomes too slow

Change cartridge when the difference between the inlet pressure and the system outlet gauge is greater than or equal to 20 psi

Service flow rate must not exceed 5.0 gpm

Always flush the filter cartridge to drain for fifteen minutes at time of installation and cartridge change

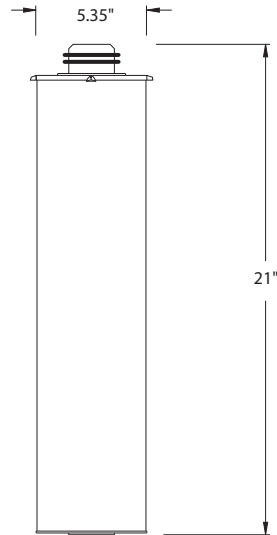
