Use of the optional Water Block External Reset Device (EV9503-20) is recommended. Internal reset can be used instead, however, this does require disconnecting the water line

Use of the optional EV3138-61 GHT Adaptor is recommended for installation with garden hose type (GHT) connectors

Optional clip (part number 244454) can be used for mounting during installation




