Merchandiser will feature textured finish on interior and exterior. Energy efficient LED interior lighting will be standard. Other standard features include adjustable torsion bar hinges, top mounted low profile interior fan housing, electric condensate evaporator, metal legs with 6"-7" adjustable range, independent on/off light switch and black door rails and handles. Five white epoxy-coated shelves (four cantilever and one bottom) with price tag molding per door will also be standard.

The refrigeration system is to be top

mounted, self-contained and use R-134a refrigerant. The temperature range will be  $34^{\circ}$  to  $41^{\circ}$ F ( $1^{\circ}$  to  $5^{\circ}$ C).

Merchandiser to have standard limited two year parts and labor with additional three year coverage on compressor part.

Merchandiser to be UL, C-UL and NSF listed as well as ENERGY STAR qualified.
