# **Specification Components**

- Dining height, upholstered sled stacking chair for educational, hospitality, public assembly and special event seating
- Chair features
  - $\circ$  7/16" diameter steel rod frame
  - 1/4 inch padded polyurethane foam seat mounted to polypropylene seat core
- Each chair weighs 14.3 pounds

#### Frame

- Constructed of 7/16" diameter steel rod frame
- Finished with an abrasion and rust resistant chrome-plated finish
- Chair Feet
  - Styrene-Butadiene Copolymer feet are non-slip, non-marring, and long-lasting

#### Seat Frame & Pad

- Seat attached to frame with six (6) 4.5mm x 9.0mm and four (4) 4.0mm x 8.0mm screws
- Back attached to frame with two (2) inner hex screws measuring 6.0mm x 8.0mm
- Seat Pad
  - <sup>1</sup>/<sub>4</sub>" thick, 2.5 lb/cu. ft. density, resilient polyurethane foam pad holds it shape, for maximum comfort
  - Cushion and seat back fill materials meet California Home Furnishings flammability requirements according to CA TB 117
  - V398-20 Fabric Standard
    - 100% polyester
    - Abrasion Resistance (ASTM D4966-98(2004)) of 30,000 "double rubs" with no yarn broken
- Seat Dimensions: 17 5/8" wide x 17 1/8" deep
- Seat Height: 18"

# **Stacking & Storing**

- 16 Chairs stacked on floor measure 48.75" high
- 25 Chairs stacked on dolly measure 20" wide x 37.5" long x 65" high and requires 5.2 sqft / 28.2 cubic feet of storage space

- All metal parts are treated for corrosion resistance and chrome adhesion
- Fasteners are zinc plated
  - Frame is finished with durable chrome plating o Offers superior resistance to abrasion, marring & scratching
